

Terms and conditions –

By accepting these terms and conditions you are accepting to the following terms and conditions between you henceforth called YOU and ARAM Health Management of America henceforth called ARAM.

The term 'Provider' in this contract refers to the provider of health related services to you. Thus a provider can be a doctor, a pharmacist, a hospital, a physical therapist, a nurse, a nurse practitioner, a physician assistant, a midwife or any other provider of medical services to you.

2. Membership to this program is exclusively for your personal use only. YOU will use this program for your personal use only.
3. As a purchaser of this membership YOU are the only authorized party for this membership.
4. Sharing, copying, transmitting this program in any format print, electronic, audio or video or any format that is not yet defined with the intent of distribution or sharing with non authorized party will be a violation of this contract.
5. If YOU share, copy, distribute this membership or its access to contents you can and will be held responsible for all the losses financial and otherwise that ARAM suffers or may suffer in the future from your such unauthorized use of this program.
6. Any use of this program other than intended is a violation of the contractual agreement between YOU and ARAM.
7. YOU understand that and agree that ARAM is only an educational service.
8. YOU understand that and agree that ARAM is not a health plan.
9. YOU understand that and agree that ARAM is not a provider of any kind including the doctor, the pharmacist or the lab but not limited to them.
10. YOU understand that and agree that your medical care will continue under your own provider.
11. YOU understand that and agree that ARAM will not provide any health care neither in emergency situation nor in non-emergency situation.

12. YOU understand that and agree that ARAM will not prescribe any medication or non medical disposable item for you.
13. YOU understand that and agree that ARAM will not alter the dose of any medication for you and that the responsibility to do so stays with your provider.
14. YOU understand that and agree that ARAM will not make any medical decision/s for you or on your behalf.
15. YOU understand that and agree that ARAM will not advise you for or against any medical procedure.
16. YOU understand that and agree that ARAM will not advise you for or against any medical test
17. YOU understand that and agree that ARAM will not advise you for or against any medication
18. YOU understand that and agree that ARAM will try to provide the most optimal medical information available based on standard recommendations, your health remains your own responsibility.
19. YOU understand that and agree that ARAM strongly recommends you discuss issues raised from this interaction with your provider before you make any changes in your regimen, medication or any other aspect of life – for example exercise.
20. YOU understand that and agree that ARAM can not be made responsible for decisions you make based on what you learn but without consultation with your doctor. ARAM does not wish to replace your provider but wish to strengthen your relationship with your current provider that you can fully benefit from that relationship.
